Subject: Report.

Sir,

I have the honour to state that today ie. 14/01/2019 at about 3.15 Pm I came from Moreh for Sangayumpham with 3(three) unknown male persons on my Maruti Van bearing regd. No. MN05A/6113 silver in colour being hired/reserved by them. However the way, they asked me to go to Lalong Turel Ahanbi instead of Sangayumpham. When we reached at Lilong Turel Ahanbi Dam Mathak at about 7:10 pm, they (three unknown persons) suddenly attacked me for the reason not known to me by using lethal weapons like iron rods by hitting on my head and they also punched me on my neck and face. Later they kicked me out of my vehicle and taken away my vehicle, money bags with Rs. 7000 and one mobile handset Samsung J7 Prime having sim card bearing no. 9366289234 (Reliance Jio) amounting about Rs. 12,500/- approximately. As a result of which I got multiple injuries on my persons. The approximate value of my vehicle is Rs. 200000/- (Two Lakh) only.

It is therefore requested to take up necessary legal action against the culprits / hijackers according to law.
