Today i.e. 17/01/2019 at 1610 hrs. received a reliable information that on the same day at about 1605 hrs. one motorbike KTM orange white in colour bearing Regd. No. nil coming from Thoubal side towards Imphal sides dashed at the back side of one Honda Dio bearing Regd. No. MN02B-8775 which was proceeding in the same direction along NH-102 near the Girl High School, Lilong Heinou Makhong due to rash and negligent driving on the part of unknown rider of motorbike KTM.
