I have the honour to report that on 23/01/2019 at about 06.30 pm one Md.Boicha 31yrs S/O Md.Salam @ Tomba of Lilong Haoreibi Chegaipokpi called out me from my house and forcibly dragged me in Magic Van which was brought by him and forcibly raped me inside the vehicles. Further, he brought me at the house of Mrs. Majida 48 yrs D/O (L) Md. Tomba located at Lilong Haoreibi Makha Leikai konjil pretending that he will marry me and again he repeated raped me there. However in the next morning the said Md. Boicha with the help of Majida's family members fled away leaving me there.

It is therefore requested to take up necessary legal action against the culprits as per provision of law.
