Today i.e on 02/02/2019 at 11:45 pm received a specific information that one Md. Amir Khan (25)yrs S/oMd. Maheruddin of Lilong Haoreibi Makha Leikai Salam Manung, Thoubal District and some of his associates kept conceal a stolen Alto Car at the house of Md.Amir Khan. Accordingly I informed to my senior officers and with the supervision of OC Lilong PS I along with my police team of Lilong PS immediately rushed to the house of Md. Amir Khan (25)yrs S/o Md.Maheruddin of Lilong Haoreibi Makha Leikai Salam Manung. Our police team reached at the house of Md.Amir Khan at 00:10am of the next day i.e 03/02/2019 and searched his house and the surrounding areas. In that one Alto Lxi without Regd. Nos. silky in colour bearing Chassis Nos. MA3EYD81S00 285318 and engine nos. F8DN 3048116 was found parked at the courtyard of his house in a very suspicious manner. However Md. Amir Khan and his associates managed to escape taking the advantage of darkness. On verification the said vehicle, it is highly suspected to be stolen vehicle and kept conceal by Md.Amir Khan (25)yrs. S/o Md. Maheruddin of Liong Haoreibi Makha Leikai Salam Manung, Thoubal District and some of his associates. The said vehicle was seized by observing necessary formalities at the spot.

The said seized vehicle is brought to the station and handed over to you for taking further necessary action.
