I have the honour to report that on the 02/02/2019 at about 6:30 am my son namely Fm. Mukhtar Alam aged about 13 yrs. left my home for Madrassa Darul Uloom (Islamic Institute) located at Lilong Haoreibi Turel Ahanbi for his Islamic study along with his younger brother namely Fm. Azad Alam. On the same day at around 11:30 pm his younger brother Fm. Azad Alam informed me that his elder brother was found missing from Madrassa Darul Uloom. I along with my family members searched all the suspected areas to find but could not trace out till date. My son is highly suspected to be kidnapped by some unknown person/persons for any wrongful purposes.

So, I therefore requested you may kindly taken up necessary legal procedure as to trace out my missing son at the earliest.
