Today i.e, 05/02/2019 at around 2.30 pm while I was in the office of Lilong PS, received a reliable information from one of my source that one person namely Md. Abdul Barik@ Amubi(42) yrs. S/o Md. Kadir of Kiyamgei Awang Leikai is selling cough syrups which contains codeine phosphate and some cough syrups bottles are kept concealed in the Honda Activa bearing No. MN01U-9971 (White in colour) which was parked in front of Primary Health Centre, Lilong near Sky Pharmacy, Lilong. After verifying the veracity of the source report, I recorded the information in writing and a copy of the said report was furnished to SP/ Thoubal for information. Immediately, I along with police team assisted by ASI. Md. Tamijur Rahaman of Lilong PS rushed to the said place without obtaining search authorization as there was great chance of escaping of offenders and concealing the drugs. At about 2.45 pm of the same day, we reached the spot and seeing us, the owner of Honda Activa ran away from the spot. Our party chased him but he managed to escape by taking advantages of crowd. Therefore, we cordoned the Honda Activa requested two persons available there to be witness while searching the Honda Activa. In presence of the witnesses we conducted search of the Honda Activa. During the search, found one transparent polythene plastic bag in the tool box of Honda Activa. The suspected transparent polythene bag was opened in presence of the witnesses. Or opening it, detected 13 nos. of KOF-T cough syrup bottles(100 ml each) which contains 10(ten) mg codeine phosphate in each 5ml which is contravened substance under ND&PS Act. On further checking all the KOF-T cough syrup bottles were found labelled. Batch BL-869, Mtd. Dec. 2018 Exp. Nov. 2020. On weighing, one bottle of KOF-T cough syrup weighed 135 gm, i.e. altogether total(135x13)=1755 gms. Then two bottles of KOF-T cough syrup were taken out and put inside the two brown envelops, packed and marked as "A1" & "A2" as original and duplicate representation samples respectively. The remaining 11(eleven) bottles of KOF-T cough syrups were put inside the original transparent polythene plastic bag, then packed it with white wrapped cloth and marked as "A" as parent exhibit. The exhibits marked as A1, A2 & A were sealed with wax in presence of the witnesses and seized the exhibits along with the Honda Activa at 3.00 pm of the same day from the spot by observing formalities.

Hence a sou moto case under FIR. NO.21(02)2019 LIL.PS. U/S, 21(b)ND & PS Act. is registered for investigation.
