Officer-In-Charge Lilong Police Station Thoubal District, Manipu On 07/02/2019 at around 08:00 pm based on a specific information regarding the selling of illegal drugs like SP capsules at the house of Md. Arif aged about 26 years S/O Md. Salaoddin @ Aku Lilong Haoreibi Awang Leikai Tera Makhong, two teams of Lilong Police Station led by myself assisted by SI Md. Islauddin and ASI Laishram Tikendro of Lilong Police Station rushed to the house of Md. Arif. On reaching the house our police team cordon the house and started to search the house in that found 11,474 (eleven thousand four hundred seventy four) nos. of suspected SP capsules (it refers to FIR No. 23(02)2019 LIL PS U/S 21(c)/25/29 ND & PS Act).

When the police team tried to perform the procedures for the seizure of drugs under ND & PS Act, the family members of Md. Arif namely (1) Md. Salaoddin aged about 54 years S/O Ibo of Lilong Haoreibi Awang Leikai Tera Makhong, (2) Mrs. Gaho (52) W/O Md. Salaoddin of do , (3) Mrs. Khursida (30) W/O (L) Md. Najir Ahamed of Lilong Lou Tara A/P -do-, (4) Miss Peku (28) D/O Md. Salaoddin of -do-, (5) Md. Arif (26) Md. Salaoddin of -do-, (6) Mrs. Suriya W/O Md. Arif of do (7) Md. Imtiaz (21) S/O Md. Feijuddin of do started to organize a violent mob by calling out the people of their locality. Then many people numbering about 100-150 people came out and started to attack our police team violently by using deadly weapons like knives, iron rods swords, wooden planks etc. Our police team tried to convince the crowd but in vain. Further, Mrs. Gaho (52) W/O Md. Salaoddin (mother of Md. Arif), Mrs. Khursida (30) W/O (L) Md. Najir Ahamed of Lilong Lou Tara and some other women lied down on the ground in front of Police vehicle thereby obstructing our team to perform our duty. Besides some localities motivated by the above persons surrounded our vehicles, pelted stones and even assaulted our police team. As a results of which, 3 (three) police personnel namely (1) HC Abdul Kalam of Lilong PS, (2) C/No. 0908300 Md. Alaoddin of do and (3) VDF No. 147 Tekcham Sanjoy Singh of -do- were injured on their persons and damaged the police vehicle. Later the injured persons were evacuated to hospital for medical treatment.

Hence a Suo- Motto case under FIR No. 24(02)2019, LIL PS U/S 147/148/149/189/326/353/427 IPC is registered for investigation.
