Sir,

I have the honour to report that today ie, 19/02/2019 at around 4:30 pm while I and my friend namely Md. Safurddin aged about 45 yrs. S/o (L) Md. Anamuddin of Yairipok Changamdabi were driving with our Tata Tipper Hywas proceeding from South to north along the inter village road of Lilong Turel Ahanbi Upakthong, suddenly the following culprits namely 1) Md. Abdul Hasim @ Amu aged about 42 yrs. S/o Md. Abdul Samad of Lilong Turel Ahanbi Upakthong Makha, 2) Md. Sirajuddin @ Buya Seraddin aged about 51 yrs. S/o (L) Md. Abdul Salam of Lilong Atoukhong Maning Leikai and 3) Md. Azmir aged about 34 yrs. S/o Md. Rajab Ali of Lilong Darul Uloom Maning restrained our moving vehicles and intentionally assaulted my friend Md. Safurddin who is the driver of Tata Tipper Hywa bearing registration no. MN01-9206 using deadly weapons like stones, hammer, bamboo sticks etc screaming "why are you driving this route and is going to be killed you with ablazing vehicles too " Besides they attacked our vehicles resulting partly damaged of the front portion. Consequently Md. Safurddin has been injured his persons especially head injury and now hospitalized at the Noor Hospital and Research Institute, Lilong for treatment.

So, I therefore, request you kindly to take up necessary action against the aforesaid culprits and also be observed free fear of servicing at the same route.
