I have the honour to report that in the evening of 18/01/2019, I was calling by my wife namely Sahanaj 2 Roji D/o Md. Nijamuddin through mobile phone and went at her house located at Lilong Haoreibi Makha Leikai Lairabakhong while I was staying at her house. I was forcibly kidnapped by Md. Burhanuddin 30 yrs S/o Md. Nijamuddin of Lilong Haoreibi Makha Leikai Lairabakhong and his 10(ten) nos. of unknown associates at about 6:00 pm and again forcibly brought me at the house of one Councilor namely Md. Islamuddin Ward No. 3 Wangoi Municipal Council located at Paobitek and forcibly taken away my signature on a Non Judicial stamp paper on the ground of marriage or divorce of my wife with an intention of threatened by 1) Md. Minhaj Khan 30 yrs. S/o (L) Haji Kiram of Lilong Haoreibi Makha Leikai Lairabakhong 2) Md. Basir Ahamed 32 yrs S/o Md. Mamei of Paobitek Maning Leikai 3) Md. Aziz Khan 25 yrs S/o Md. Abdul Hakim of Wangoi and 4) Md. Islamuddin, Councillor, Wangoi Municipal Council Ward No. 3.

It is therefore requested to take up necessary legal action against the culprits as per provision of law.
