Today i.e. 28/02/2019 at about 09:00 am received reliable information from my personnel source that some unknown person/persons suspected to be drug peddlers were gathering at the house of Md. Noorul Hassan located at Lilong Bazar. Then, I informed to Shri Dr. S. Ibomcha Singh, MPS, Superintendent of Police, Thoubal about the source report in written. Quickly, I along with SI. Md. Wakibuddin, ASI. Md. Ajahar Ali & ASI I. Mukesh Singh and 2 (two) teams of Lilong P.S including women police personnel rushed to the said house at 09:45 am and cordoned it. Further I called out the members of that house, at that time, one person namely Md. Noorul Hassan (44) yrs, S/o. (L.) Md. Nurul Haque of Lilong Bazar said he is the owner of that house. Then I asked his opinion to search/check the house in presence of a Magistrate or a Gazetted Officer. In that he opined to search in presence of civil witnesses. Accordingly called the members of a civil organization so called ALADA (All Lilong Anti-Drugs Association), Lilong and checked the same in presence of them. While conducting the house search, we found 8 (eight) nos. of "ELTUREX" cough syrup which is containing 10 mg of codeine phosphate which was kept concealed in the pan shop, 2 (two) nos. of ELTUREX cough syrup bottles were taken out and packed and sealed into 2 (two) nos. of yellow envelopes for each original and duplicate samples marked as "A1" & "A2" respectively. The remaining 6 (six) nos. of "ELTUREX" cough syrup was packed and sealed in a box which was wrapped with white cloth and marked as "A" as parent sample.

Hence, seized the packed and sealed articles mentioned above from the spot by observing the necessary formalities at 10:50 am and arrested Md. Noorul Hassan (44) yrs, S/o. (L.) Md. Nurul Haque of Lilong Bazar at 11:00 am.

So, the seized articles mentioned above and arrested person are brought to the PS for further necessary legal action.

Hence, a suo motto case under FIR No. 30(02)2019 LIL-PS U/S: 22(a) ND&PS Act.
