Today i.e. 04/03/2019 at about 07:00 pm two teams of Lilong PS led by OC/L.I. PS assisted by ASI Laishram Mukesh Singh of Lilong PS were conducting mobile patrolling duty in and around Lilong Hangamthabi area as a preventive measures of the upcoming 17th General Lok Sabha Election 2019. On reaching Lilong Haorou Hangamthabi, one individual was seen coming out and as he saw our police team approaching towards the said area, he hurriedly ran towards a nearby house cum shop in a very suspicious manner. Immediately our teams tactically chased him and subsequently cordon the house. After that I called out the owner of the house in that one lady who identified herself as Mrs Rukshana (26) W/O Md. Abdul Hussain of Mayang Imphal Bengoon A/P Lilong Haorou Hangamthabi came out from the house cum shop. Then I informed her that I would like to search his house. On her consent, our police party entered and started to search the house cum shop. On searching, we found the said individual who ran inside the shop, hiding at the corner of the room. And he was seen while he was trying to hide one transparent greenish colour polythene containing some suspected articles at the corner of the shop. Then I spotted the articles and told him to bring out the said polythene. On opening the said polythene found 5 nos. of Cough Syrup bottles marked as "DelStal" containing 10 mg of banned Codeine Phosphate per 5 ml(as per composition labeled on the bottle) and on weighing, it weight 140 grams per bottle including the weight of bottle and total weight is 140X5=700 grams(including the weight of bottles). On further verification, he identified himself as one Md. Abdul Hussain S/O (I.) MV Abdus Salam of Mayang Imphal Bengoon A/P Lilong Haorou Hangamthabi. Then he was arrested on the spot at 07:35 pm.

Out of the 5 nos. of the Cough Syrup bottles 2 bottles of the same were taken out and put inside two yellow envelopes with 1 nos. of the Cough Syrup bottles each, packed and sealed and marked as "Z1" & "Z2" as Original and Duplicate sample exhibit respectively. And the remaining 3 nos. of the Cough Syrup bottles inside the original greenish polythene were put inside another yellow envelope packed and sealed and marked as "Z" as Parent sample exhibit.

Therefore the packed and sealed drugs were seized on the spot by preparing a formal seizure memo in the presence of witnesses at 08:10 pm. And then the arrested individual along with the seized Cough Syrups bottles were brought to this PS for further necessary formalities.

Hence, a Sun Motto case has been registered under **FIR No. 31(03)2019 LIL-PS U/S 21(a)/29 ND & PS Act.**
