On 17/03/2019 at about 11:00 pm as part of the preventive measure taken up in connection with the ensuing Lok Sabha Election, 2019, a team of Lilong Police Station led by Inspt. O. Ajit Singh, OC, Lilong PS assisted by ASI L Mukesh Singh and ASI Md. Serakhan Shah of Lilong PS including lady police under the supervision of SP/TBL, conducted patrolling and random frisking and checking in and around the jurisdiction of Lilong PS. At about 12:10 am of the 18/03/219. When our Police team was conducting frisking and checking at Lilong Haorou Hangamthabi near Baby English School, one Bajaj Royal Enfeild B/Rgd. No. MN06LA-7132 was coming from Lilong Chingkham side towards NH no 102 along Inter village road in a suspicious manner. On seeing our police team, the same vehicle stopped and the rider and pillion rider said Royal Enfield tried to escape away from the spot. However, our team managed tactically to detain them at the spot for verification. On verification, rider of said Royal infield was identified as Keisam Surka Meitei (23) S/O K. Sunamani Meitei of Kongba Laishram Leikai whereas pillion rider was identified Mrs. Marjina @ Kamala (47) yrs, w/o Md. Manikhan of Keikhu maning Leikai. Being suspicious, I informed them that I like to conduct search of the vehicle as well as their bodies in presence of gazetted officer or executive magistrate. Then, they informed me that they like to conduct search the said vehicle and their bodies in presence civil witnesses. Accordingly, I informed some members of ALADA (all Anti- Drug Association) through mobile phone to presence at the spot as civil witnesses. After some minute some members of ALADA arrived at the spot and then our lady/ police started body search of the woman namely Mrs. Marijna @ Bbilon in presence of civil witnesses and also our police team started body search of other person K. Surka. On the body search of two persons, no any illegal article was found from the person namely K. Surkan and however on the body search of other person namely Mrs. Marijna @ Kamala by our woman police constable, detected one cylindrical small plastic bottle containing some white powder suspected to be heroine no. 4 from the inner cloth of her. They were arrested at the spot at 12.25 am. On weighing the white powder suspected to be heroine no. 4, it weight 28.10 grams including the weight of small plastic container. Out of which 28.10 grams of white powders suspected to be heroine no. 4, 02 (two) grams were taken out into two small plastic polythene of 01(one) gram each and put them inside two yellow envelopes, packed and sealed and marked as "A1" and "A2" as original and duplicate samples respectively. And the remaining 26.10 grams were also put into another vellow envelope, packed and sealed and marked as "A" as parent sample in presence of witnesses. Accordingly, informed about the seizure of the illegal drugs heroine no. 4 to SP/TBL.

So, the above noted 28.10 grams of white powder suspected to be heroine no. 4 along with the Royal Enfield B/Rgd. No. MN01AE-6447 was seized in presence of witnesses by preparing a formal seizure memos at 01:00 am of 18/03/2019. The approximate market value of the seized Heroine no. 4 is Rs. 28,000/- (twenty eight thousand). Then, the two arrested persons along with the packed and sealed white powder suspected to be Herine No. 4 were brought to this Ps for further necessary legal action.

Hence, a suo motto case under FIR No. 34(03)2019 LIL-PS u/s- 21(b)/29/27 ND&PS Act has been registered for investigation.
