On 19/3/2019 at about 10:30 pm received a reliable information from my source that one drug peddler namely **Md. Abdul Manan @ Amir Khan (24)** S/O (L) Md. Abdul Hei of Lilong Haoreibi Makha Leikai Lairakhong is selling illegal drugs and now according to source report he is aspected to deal a big consignment of illegal drug heroine no. 4 at his house. Accordingly I have reduced the source report in written and submitted to my immediate senior officer. Immediately a police team of Lilong PS led by myself with members of Civil Association ALADA and my source person rushed to the house of Md. Abdul Manan @ Amir Khan (24) at Lilong Haoreibi Makha Leikai Lairakhong. When our team reached at the gate of his house at Lilong Haoreibi Makha Leikai Lairakhong, one person came out from the house holding a transparent polythene bag in a suspicious manner. My source identified him as Md. Abdul Manan @ Amir Khan. Immediately our team got down from our respective vehicles and rushed towards him. However, as soon as he saw our police team, he fled away from the spot by leaving behind the plastic polythene. Our police team chased him but he managed to escape taking the advantages of darkness. On opening the polythene detected 2 nos. of reddish colour plastic cap containing white colour substances wrapped with another plastic transparent packet which is highly suspected to be Heroin no. 4. The white colour substances were weighed separately by the weighing machine brought by us. In that the 1st plastic packet weighs 14.5 grams and the 2nd plastic packet weighs 14.9 grams. Further, raided and thoroughly search the house of the said Md. Abdul Manan @ Amir in the presence of witnesses. However the said individual is not found at his house and no any incriminating articles were also found at his house.


Out of the 14.5 grams of suspected Heroin no. 4, 4 (four) grams of the same were taken out and put inside two transparent plastic pouches with 2 grams each, packed and sealed and marked as "A1" & "A2" as Original and Duplicate Sample exhibit respectively. And the remaining 10.5 grams of the same powder is put inside the reddish colour plastic cap and again put into a yellow envelope, packed and sealed and marked as "A" as Parent Sample Exhibit.

Similarly, out of the 14.9 grams of suspected Heroin no. 4, 4 (four) grams of the same were taken out and put inside two transparent plastic pouches with 2 grams each, packed and sealed and marked as "B1" & "B2" as Original and Duplicate Sample exhibit respectively. And the remaining 10.9 grams of the same powder is put inside the reddish colour plastic cap and again put into a yellow envelope, packed and sealed and marked as "B" as Parent Sample Exhibit.

Therefore the said packed and sealed drugs were seized from the spot by preparing a formal weighing and seizure memo at 12:30 am in the presence of civil witnesses. Then I immediately inform my senior officers about the incident. Hence a Suo Motto case under **FIR No. 35(03)2019, LIL PS U/S 21(b) ND & PS Act** is registered for investigation.
