On 22/3/2019 at about 6:30 pm received reliable information from my source that one drug peddler namely Mrs. Fatima aged about 41 yrs. W/o (L) Md. Abdul Khalique Located at Lilong Hangamthabi is selling illegal drugs W.Y at her house. Accordingly I have reduced the source report in written and submitted to my immediate senior officer. Immediately a police team of Lilong PS led by myself including SI Islaouddin and woman police with members of Civil Association ALADA and my source person rushed to the house of Mrs. Fatima aged about 41 yrs. W/o(L) Md. Abdul Khalique Located at Lilong Hangamthabi. When our team reached at her house at Lilong Hangamthabi, one lady was found standing at the courtyard of the house and she tried to flee from the spot when she saw our team. In that our police team chased and detained her. My source identified her as Mrs. Fatima and as such her body search is very must require. Accordingly asked her option that whether her body may be searched in present of Magistrate or gazetted officer. In that she opined to search her body in present of civil witnesses. With her consent, our woman Police search her body in present of the lady independent witness and found one plastic packet blue in colour kept in her pocket. On opening the plastic packet some red colour capsule suspected to be W.Y Tablet and it contained 110 nos of W.Y Tablet. Out of which 5(five) no each of WY tablet were taken out and put into two yellow envelope marked as W1 and W2 as original exhibit sample and duplicate exhibit sample. And the remaining 100 nos of W.Y tablet put in one yellow envelope marked as parent exhibit. The same illegal drugs were packed and sealed in presence of the witnesses. So, she was arrested from the spot at 7:10 pm. Further the packed and sealed illegal drugs were seized from her possession at 7:20 pm. While questioning her, she disclosed that the said drugs was purchased from one person namely Md. Tarigue Ajiz aged about 22 yrs. S/o Md. Salauddin of Lilong Mairenkhum makha for selling for her wrongful gain.

On follow up action, our party rushed to the house of Md. Tarigue Ajiz aged about 22 yrs. S/o Md. Salauddin at Lilong Mairenkhum Makha. Our party cordoned and searched the house keenly and apprehended the individual being found at his house in present of the family members.

Hence a Suo Motto case under FIR No. 36(03)2019, LIL PS U/S 21(b)/29 ND & PS Act is registered for investigation.
