Sir,

I have the honour to state that today i.e 27/03/2019 at about 12:10 pm received a reliable information about one stolen of Honda Activa is kept concealed in the house of Md. Abdul Hekim aged about 33 yrs. S/o Md. Abdul Hei of Kwakta Khuman Mamang Leikai at present Lilong Leihakhong. Immediately I informed the O/C Lil-Ps about the information. Acting on the information, our 2-teams of Lilong Police under the supervision of O/C Lilong Ps. rushed to the said area. After reaching the house, our team cordoned and searched the house. On searching, one Honda Activa white in colour without registration No. was found inside the house. One person identified as Md. Abdul Hekim aged about 33 yrs. S/o Md. Abdul Hei of Kwakta Khuman Mamang Leikai was also found and detained him. On spot questioning he could not produce relevant documents of the vehicle. He disclosed that he had buying the said vehicle from one Md, Waha of Lilong Haoreibi Turel Ahanbi near Darul Uloom at the rate of Rs. 14,000/=(fourteen thousand). On verification of the Honda Activa vehicle, it was found that engine No. and chassis no. of the vehicle is JF48E-840152234 and ME4JF504CF8053391 respectively. So, the vehicle was seized from the unauthorized possession of the accused person Md. Abdul Hekim and brought up at this Ps. for further investigation.
