On 27/3/2019 at about 0630 hrs, received a secret information while our police team was on patrol duty that one person namely Md. Fajur Rahaman (45) S/o. (L) Feijuddin @ Chaoba Lilong Turen Ahanbi Khongnang Makhong is selling illegal drugs, heroin no. 4 at his house at Lilong Turen Ahanbi Khongnang Makhong and as per information, he keeps concealing the heroin no. 4 at his bed room. I informed my superior officers about the information on wireless instead of sending/submitting in written as it will delay in trapping the individual which may lead him to escape from the police arrest. Immediately our police team rushed to the house of Md. Fajur Rahaman (45) S/o. (L) Feijuddin @ Chaoba of Lilong Turen Ahanbi Khongnang Makhong. On reaching the house, called out the members of the house, in that one male and one female came out of the house and they identified themselves as 1) Md. Sakib (14) S/o. Fajur Rahaman of Lilong Turen Ahanbi Khongnang Makhong, 2) Mrs. Fajilatun @ Apabi (40) W/o. Md. Fajur Rahaman of Lilong Turen Ahanbi Khongnang Makhong. In the meantime one person was coming from paddy field towards the house through the gate of the house. Our team stopped him and when enquired, he identified himself as Md. Fajur Rahaman (45) S/o. (L) Feijuddin @ Chaoba of Lilong Turen Ahanbi Khongnang Makhong. Accordingly I along with my team have searched his house in presence of PWs and found one cylindrical (bottom) and pointed (top) bottle marked as Vinex containing some white powder suspected to be Heroin no. 4 concealing inside the blanket cover which was on his bed. When enquired about the white powder, he disclosed that the white powder is heroin no. 4 and the same belongs to him. Thus he was arrested at his house by observing proper formalities at 8:30 am. On weighing the weight of the white powder suspected to be heroin no.4. It weight about 30.6 grams including the weight of plastic bottle. On further weighing the weight of the plastic bottle is 20.5 gram and the weight of heroin no. 4 powder is 10.1 grams. Out of 10.1 gms of white powder suspected to be heroin no. 4, 2gms of which were taken out and put into two small plastic containers 1 gram each and again put into two yellow envelopes packed and sealed, marked as H1 and H2 as original and duplicate samples respectively. And the remaining 8.1 grams of white powder suspected to be heroin no. 4 was put into a yellow envelop and then packed and sealed and marked as "H" as parent sample. Then the packed and sealed yellow envelopes containing the white powder suspected to be heroin no. 4 were seized from the spot at 8:50 am by observing formalities. Then the arrested person along with the seized packed and sealed seizures had been brought to PS for further legal action.

Hence, a suo motto case under case FIR No. 38(03)2019 LIL-PS, U/S: 21(b) ND&PS Act has been registered.
