Today i.e. 30-03-2019 at 9:35pm, received a reliable information that on the same day at about 9:27pm one Diesel Auto-Rickshaw bearing registration no. MN01AC-7738 which was crossing towards eastern side proceeding from Thoubal side towards Imphal side collided with one Honda Activa brown in colour bearing registration no. nil which was also coming in the same direction in front of the Lilong Girl High School, Lilong Heinou Makhong on NH-102 due to the rash and negligent driving on the part of unknown drivers of both vehicles.
