On 05/04/2019 at about 0840 hrs, while I along with my Police team on duty at Lilong Bazaar, received a secret information from one unknown informant that one drugs peddler Md. Wazir Ahamed @ Amuba (19)yrs. S/o. (L) Md. Allaudin of Lilong Uku Maning near oil pump is selling illegal drugs such as cough syrup bottles at his house and informant also gave information that the drug peddler was then trying to shift a huge quantities of illegal cough syrup bottles from his house to somewhere else. Immediately I informed about the information to my superior officers on wireless instead of sending/submitting in written as it will delay in trapping the individual which may lead him to escape from the police arrest and he will conceal the illegal drugs. Without delaying, I along with two teams of Lilong police station assisted by ASI Laishram Mukesh Singh rushed to the house of Md. Wazir Ahamed @ Amuba (19) S/o. (L) Md. Allaudin at Lilong Uku Maning. When we reached at the house, one person came out of the house and started running on seeing our police team. Our team managed to detain him. On verification, he identified himself as Md. Wazir Ahamed @ Amuba (19) S/o. (L) Md. Allaudin Lilong Uku Maning. Then our police team searched his house in presence of civil witnesses and found two sacks at his bed room one was grey in colour and other was green in colour. When opened the two sacks, we found illegal cough syrup bottles containing 10 mg of codeine phosphate per 5ml (as per composition labelled on the bottle). In the two sacks on questioning he revealed that same illegal cough syrup bottles belonged to him. Thus, the person was arrested at the spot at 9.45 am by observing formalities. On counting the nos. of cough syrup bottles of the grey colour sack, we found 262 nos. of cough syrup bottles and on weighing, the weight of 01(one) bottle is 140 grams including the weight of bottle and the weight of 262 nos. of cough syrup bottles is 36.68 Kg including the weight of bottles. Out of which, 02(two) bottles were taken out and put into two yellow envelopes 01(one) bottle each, packed and sealed and marked as "C1" and "C2" as original and duplicate samples respectively. And the remaining 260 nos. of bottles were packed and sealed with the same sack by white cloth and marked as "C" as parent sample. On counting the nos. of cough syrup bottles of the green colour sack, we found 242 nos. of cough syrup bottles and on weighing, the weight of 01(one) bottle is 140 grams including the weight of bottle and the weight of 242 nos. of cough syrup bottles is 33.88 Kg including the weight of bottles. Out of which, 02(two) bottles were taken out and put into two yellow envelopes 01(one) bottle each, packed and sealed and marked as "D1" and "D2" as original and duplicate samples respectively. And the remaining 240 nos. of bottles were packed and sealed with the same sack by white cloth and marked as "D" as parent sample. The total nos. of cough syrup bottles is 504 and total weight is 70.56 Kg and its market value is about Rs.1,51,200/-.

Then the packed and sealed illegal cough syrup bottles containing codeine Phosphate were seized from the spot at 11:50 am in presence of witnesses by observing formalities. Then the arrested person along with the seized packed and sealed seizures had been brought to PS for further legal action.

Hence, a suo motto case under case FIR No. 41(04)2019 LIL-PS, U/S: 21(c)/29 ND&PS Act has been registered.
