Today i.e. 07/04/2019 at about 0900 hrs two teams of Lilong PS led by OC/LIL PS assisted by ASI Laishram Mukesh Singh of Lilong PS including WPC's and 03 (three) teams of CDO Unit, Thoubal led by SI. Ramesh Singh (G-58), Havildar Th. Wilson Singh (G-55) and HC. K. Bobby Singh (G-62) were conducting cordoned and search operation (CASO) of the houses located in and around Lilong kaleikhong Makok area in c/w the visit of the Hon'ble Prime Minister of India at Imphal. When our police team approached at the house courtyard of one Mrs. Thoibi (45) W/o Md. Ziauddin of Lilong Kaleikhong Makok, one woman was found sitting on a stool (morah) at the courtyard of that house in a very suspicious manner. On verification, she identified herself as Mrs. Thoibi (45) W/o. Md. Ziauddin of Lilong Kaleikhong Makok. When our police team asked to stand up, she denied us. Then our Women police forcibly pulled her up and get her to move 2/3 steps from her initial position. On opening the fallen down black colour polythene carry bag, we found some illegal cough syrup bottles in a transparent polythene bag and some blue colour cylindrical capsules suspected to be SP-Capsules (Spasmo proxivon) inside the same black colour polythene bag. On counting the nos. of cough syrup bottles, we found 08(eight) nos. marked as "**Bolirex- New**" containing 10 mg of codeine phosphate per 5ml (as per composition labeled) worth about Rs.2400/- and 310(three hundred and ten)nos. of blue colour cylindrical capsules suspected to be SP-capsules worth about Rs.4650/-. On questioning she revealed that same illegal drugs belonged to her. Thus, she was arrested at the spot at 1030 hrs. On weighing, the weight of the weight of 01(one) cough syrup bottle is 140 grams including the weight of bottle and total weight of the cough syrup bottles is  $140 \times 8 = 1.12$  Kg including the weight of bottles and the weight of 310 nos. of cylindrical capsules suspected to be SP-capsules is 20.15 grams. Out of 08 bottles of cough syrup bottles, 02(two) bottles were taken out and put into two yellow envelopes 01(one) bottle each, packed and sealed and marked as "C1" and "C2" as original and duplicate samples respectively. And the remaining 06 nos. of bottles were packed and sealed in an another yellow envelope and marked as "C" as parent sample and out 310 nos. of blue colour capsules suspected to be SP-Capsules, 10 nos. of capsules were taken out and put into two yellow envelopes 05(five) capsules each, packed and sealed and marked as "S1" and "S2" as original and duplicate samples respectively. And the remaining 300 nos. of capsules were packed and sealed in another yellow envelope and marked as "S" as parent sample

Therefore the packed and sealed illegal drugs were seized on the spot by preparing a formal seizure memo in the presence of witnesses at 1150 hrs. And then the arrested woman along with the seized illegal drugs were brought to this PS for further necessary investigation.

Hence, a Suo Motto case has been registered under **FIR No. 42(04)2019 LIL-PS U/S 21(a)(b)/29 ND & PS Act.**
