On 20/3/2019 at about 3:30 pm received a secret information from my source that one Makakmayum Ziaur Rahaman (28) S/O Md. Abdul Latip of Lilong Ubak Thong Mathak Leikai is selling illegal drugs and now according to source report he is expected to deal a big consignment of illegal drugs at Lilong Turel Ahanbi Dam area. Accordingly I have reduced the source report in written and submitted to my immediate senior officer. Immediately a police team of Lilong PS led by myself with members of Civil Association ANJUMAN and my source person rushed to the area. On reaching the informed place, our police team waited for some time and thereafter at about 4:30 pm spotted a person who was approaching towards the place on a Honda Activa 3G white in colour bearing registration no. MN0-70931 in a very suspicious manner. My source identified him as Makakmayum Ziaur Rahaman. Immediately our team rushed towards him and when he saw our police team he turn around and try to flee way from the spot. Our police team managed to detain him. On verification he identified himself as Makakmayum Ziaur Rahaman (28) yrs, S/o. Md. Abdul Latip of Lilong Ubak Thong Mathak Leikai. Our police team searched the vehicle Honda Activa 3G bearing registration no. MN0-70931 in presence of the independent witnesses and found one black polythene bag inside the tool box of the vehicle. On opening the black polythene bag, found blue cylindrical capsules suspected to be SP (spasma primvon) capsules wrapped with another plastic transparent packet and white tablets suspected to be N-10 (Nitrosun-10) tablets wrapped with another plastic transparent packet. On questioning he revealed that the blue cylindrical capsules were SP capsules and white tablets were N-10 tablets. Further, he disclosed that he bought the same from one Md. Ithemba s/o Md. Rahimuddin of Lilong Ubak Thong Mathak Leikai for selling to his customer drugs users for his wrongful gain. On counting, nos. of suspected SP capsules was 1,430 (one thousand four hundred and thirty) worth about Rs. 14300/- (rupees fourteen thousand three hundred) in local market while nos. of suspected N-10 tablets was 200 (two hundred) worth about Rs. 2400/- (rupees two thousand and four hundred) in local market. On weighing, 1,430 nos. of suspected SP capsules weighed 862.2 grams while 200 nos. of suspected N-10 tablets weighed 138 grams.

Out of 1,430 nos. of suspected SP capsules, 20 (twenty) nos. of same capsules were taken out and put 10(ten) each of the same suspected SP capsules in two yellow colour envelopes, packed and sealed and marked as "S1" and "S2" as original and duplicate sample respectively and the remaining 1410 (one thousand four hundred ten) nos. of same suspected SP capsules were put into a yellow colour envelope, packed and sealed and marked as "S" as parent sample.

Similarly, out of the 200 nos. of suspected N-10 tablets, 20 (twenty) nos. of same tablets were taken out and put 10(ten) each of the same suspected N-10 tablets in two yellow colour envelopes, packed and sealed and marked as "N1" and "N2" as original and duplicate sample respectively and the remaining 180 (one hundred eighty) nos. of same suspected N-10 tablets were put into a yellow colour envelope, packed and sealed and marked as "N" as parent sample.

Therefore, the Vehicle Honda Activa white in colour bearing registration no. MN0-70931 and the above packed and sealed drugs were seized from the spot by preparing a formal weighing and seizure memo at 05:30 pm in the presence of civil witnesses and arrested the accused person namely Makakmayum Ziaur Rahaman (28) yrs, S/o. Md. Abdul Latip of Lilong Ubak Thong Mathak Leikai at 05:35 pm. Then I immediately inform my senior officers about the incident. Hence a Suo Motto case under FIR No. 45(04)2019, LIL PS U/S 21(b)/22(c) ND & PS Act is registered for investigation.
