Today, i.e. 25/4/2019 at about 11.30 am received a reliable information from my source that some goods lifters were loitering in an around Lilong Bazar area, then, I informed to my senior officers of Thoubal district rushed to the Lilong Litan Makhong area led by me assisted by ASI Md. Serakhan of Lilong PS. On reaching the spot our police team was conducted frisking and checking at Lilong Litan Makhong area. In the meantime one unknown person was coming on foot from the Lilong Bazar side towards Lilong Litan Makhong area side very suspicious manner along with one empty cylinder, one Tulu machine 120 volt and one multiple cutter machine. He was detain for verification, on verification he identified himself as Ngairambam Romi Meitei 38yrs S/O.(L) Ng. Jugeshor Meitei of Singjamei Thongam leikai, District- Imphal West Manipur. Immediately, I called some members of ALADA (All Lilong Anti Drugs Association) through mobile phone. After some minute, some member of ALADA arrived at spot. On interrogation with ALADA member, he disclosed that the said goods was stolen by him from the Singjamei side.

On spot, he was arrested on the same day i.e. 25/4/2019 at 12.30 pm and seized the said stolen items by observing formalities in presence of the witnesses.

Hence a sou Motto case under FIR NO.47(04)2019 LIL-PS U/S 379 IPC is registered for investigation.
