Today i.e 11/05/2019 at around 0045hrs while I was in the office of Lilong PS, received a reliable information from one of my source that one person namely Md. Sajid (18) yrs. S/o Md. Abdul Hasim of Lilong Turel Ahanbi Boroi Makhong is selling cough syrups which contains codeine phosphate and some cough syrups bottles are kept concealed in the his house Lilong Turel Ahanbi Boroi Makhong. After verifying the veracity of the source report, I recorded the information in writing and a copy of the said report was furnished to SP/ Thoubal for information. Immediately, I along with police team assisted by ASI. L. Mukesh Singh and ASI Md. Serakhan Shah of Lilong PS rushed to the house of Md. Sajid 18 yrs. S/o Md. Abdul Hasim of Lilong Turel Ahanbi Boroi Makhong without obtaining search authorization as there was great chance of escaping of offenders and concealing the drugs. At about 0115 hrs of the same day, we reached the spot and seeing us, the owner of the house namely Md. Sajid (18) yrs S/o Md. Abdul Hashim of Lilong Turel ahanbi Boroi Makhong ran away from the spot. Our party chased him but he managed to escape by taking advantages of darkness. In presence of the witnesses we conducted search of the house of said Md. Sajid 18 yrs. During the search, found 5(Five) nos. of "MECODIN" cough syrup bottles which contains each bottles 10(ten) mg codeine phosphate & Chlorpheniramine Maleate 100 ml bottles beneath the bed of Md. Sajid 18 yrs. Then two bottles of "MECODIN" cough syrup were taken out and put inside the two yellow envelopes, packed and marked as "C1" & "C2" as original and duplicate representation samples respectively. The remaining 03(Three) bottles of "MECODIN" cough syrups were packed and sealed in a yellow envelop which was marked as "C" as parent sample in presence of the witnesses and seized the exhibits at 0140 hrs of the same day from the spot by observing formalities.

Hence, a suo motto case under FIR No.50(05)2019 LIL-PS u/s 22 (a) ND & PS Act has been registered for investigation of the case.
