

Sir,

I have the honour to report that, today ie. 23/05//2019 at around 04:15 pm while I was returning home in my Honda Activa from Lilong Bazar, on reaching at the IVR of Lilong Chingkhram Maning Ubakthong suddenly the above noted two accused persons halted me and intentionally stabbed with an attempt to kill me by holding deadly weapons such as sword and stick in presence of general public in view to retaliate the arrest of his brother Md. Ziaur Rahman on the charge of possessing illegal drugs by the members of ANJUMAN, Lilong on the 20th April 2019. As result of which, I received cut bleeding injury on my left hand and other injuries on my persons and evacuated to the hospital for medical treatment.

So, I therefore, request you kindly to take up necessary legal action against the noted culprits at the earliest.
