Today i.e. 26/05/2019 at 8:50 pm received information that on the same day at about 8:45 pm one Honda Dio bearing Regn. No MN04D-7742 driven by Md. Imtiaz 18 yrs s/o Md Junab Ali of Thoubal Moijing Achouba proceeding from Thoubal towards Imphal side Knocked down one pedestrian boy namely Md. Abid aged about 17 yrs S/o Md. Malik of Sora Maning Leikai along the NH-102 at Lilong lpham near a Hotel due to rash and negligent driving on the part of Honda Dio rider. As a result of which, the Pedestrian boy and the rider of the Honda Dio received serious injuries on their persons and evacuated to the Noor Hospital for medical treatment as well as the involved vehicles was partly damaged.
