

Today i.e. 05/06/2019 at 8:30 pm received information that on the same day at about 8:20 pm two Honda Activa (one 3G and one 5G) bearing Regn. No. Nil driven by two unknown drivers proceeding from Lilong towards Ushoipokpi side were knocked down by one Maruti Alto LXI B/Regd. No. MN01X-6149 along the NH-102 coming from opposite direction towards Imphal side at the junction of Lilong Kaleikhong due to rash and negligent driving on the part of Alto Driver and escaped from the spot leaving behind the scene. As a result of which, the two Honda Activa drivers were received serious injuries on their persons and evacuated to the Noor Hospital and Research Centre, Lilong for medical treatment as well as the involved vehicles were badly damaged.

Hence, a suo motto case under FIR No. 58(06)2019 LIL-PS U/S- 279/338/427 IPC has been registered for investigation.
