Sir,

I have the honour to report that on 04/06/2019 at 04:10 pm received reliable information that one unidentified male dead body was found at the paddy field of Lilong Nganglou Loukon at Lilong Haoreibi Makha Leikai, about 5 kms south west of the police station.

Hence an UD case No. 02/LIL PS/2019 dated: - 04/06/2019 U/S 174 Cr.P.C. has been registered for investigation.

During the course of investigation, the dead body was identified by his father as one **Md. Washim Ahamed (27)** S/O Haji MV Ziouddin of Lilong Haoreibi Makha Leikai, Konjil. Conducted inquest over the dead body in the presence of Mobile Forensic Unit, Imphal East and his family members. Seized the deceased's black keypad NOKIA mobile handset along with one airtel sim card having no. 6909573503 on production by the father of the deceased person. Then the dead body has been deposited to JNIMS Mortuary for Post mortem examination. On spot inspection, examined the Complainant of the case in that he fully corroborated with the OE lodged by him. Visited and inspected the spot very minutely. Drew a rough sketch map of the PO with its proper indexes.

On 06/06/2019 conducted Post mortem examination over the dead body by Dr. Bijen Ch, Demonstrator, Department of Forensic Medicine JNIMS, Imphal East and the dead body have been handed over to family members of the deceased person.

On examination of PWs of the UD case, the undernoted persons are highly suspicious in framing a conspiracy in the murder of the deceased person. Hence the undernoted persons were arrested on 07/06/2019 for proper investigation.

It is therefore requested to kindly register a regular F.I.R. fo proper investigation of the case fo justice.
