Today i.e. 07-06-2019 at 5:45 pm, received reliable information that on the same day at about 5:30pm one Maruti Omni Van bearing registration no. MN01X-5317 which was coming from Thoubal side towards Imphal side collided with one Tata Hexa bearing registration not known which was proceeding towards Thoubal collided each other at near Waithou Stone crusher along the NH-102 due to the rash and negligent driving on the part of unknown drivers of both vehicles. As a result of which, the driver of Maruti Omni Van and 5(five) occupants have been injured on their persons and evacuated to the Raj medicity, Imphal for medical treatment. Both the vehicles were also partly damaged.
