Subject: - Report

Madam,

I have the honour to state that today i.e. 20/06/2019 at around 02:40 am one Md. Atao Rahaman (28) S/O (L) Md. Abdul Karim @ Ibosana of Lilong Hangamthabi have stolen ½ gunny sack of betel nuts from the premises of my house. I chased him to stop but he hurriedly ran away opening the front gate which is lock from inside. In the month of Ramjan 2019, midnight at around 02:00 am he was seen by Mrs Ruhina W/O Md. Iqbal Hussain of Lilong Hangamthabi stealing ½ gunny sack of betel nuts and he ran away quickly jumping the southern side of the neighbour's wall. Then on 13/06/2019, at midnight he came to my house to steal some articles. As I saw him I shout and chased him but he ran away very quickly leaving behind his chappal, one gunny bag and one nylon bag. Also in the month of Ramjan 2019, I have lost one Tullu water pump and 2 spades from my house. For that too, I have a huge suspicion on him. I went to his house and warned him several times as he is my locality but he dares to continue stealing my property from my house from my premises.

It is therefore requested to kindly take up necessary legal actions against the accused person.
