I have the honour to state that yesterday i.e. 21/06/2019 at about 11:30 am while I was doing my household chores, I was assaulted badly by my younger brother-in-law namely, Md. As a result of which, I was sustained serious injuries on my body persons and evacuated to PIIC, Lilong and then to RIMS, Lamphel for medical treatment.

So, I therefore, request you kindly take up necessary legal actions against the culprit at the earliest.
