Subject: Report.

Sir/Madam,

I have the honour to report that on 25/06/2019 at about 07:00 p.m., while a team of CDO/TBL led by Inspt. N. Sadananda Singh, OC/CDO-TBL assisted by SI Ramesh Singh and Hav. H. Tikendrajit under the supervision of Okramcha Wangkhomba, MPS, Dy. SP(CDO) Thoubal conducting frisking and checking at Lilong kaleikhong near Bridge, one unknown youth holding a black plastic polythene bag was coming from NH-102 towards Lilong Kaleikhong. On seeing us, he tried to escape but our team over powered and detained him for verification and checking.

On preliminary verification, the unknown youth identified himself as Md. Arif Khan (28) S/O Md. Sahabudin of Darul Uloom Mathak, Lilong Haoreibi Turel Ahanbi. Subsequently on checking him and his belongings 1(one) plastic polythene bag black colour was detected from him.

On questioning what was inside the black polythene bag, he said it contained some medicines. On being asked to open the said black polythene bag to check it, he refused to do so. As he refused to open the black polythene bag, became more suspicious that the bag might be containing contraband items. He was given an option whether he would like his belongings to be checked before a Magistrate or a Gazetted Officer or in presence of any independent witnesses. He stated that the belongings be checked in presence of any independent witnesses or a Gazetted Officer. In presence of Shri. Okramcha Wangkhomba, MPS, Dy. SP(CDO) Thoubal the black polythene bag was opened and checked. In that, 35(thirty-five) bottles of Rodcuff-C 100 ml (10 mg of Codiene Phosphate per 5 ml as per composition) were found contain inside the said black polythene.

Two samples of 2 Bottles of Rodcuff-C each of the suspected psychotropic drug contained in the said Black plastic bag have been taken out as original and duplicate samples, packed and sealed in two separate yellow envelopes marked as "A1" and "A2" respectively. The remaining 31(thirty-one) bottles of Rodcuff-C is properly packed and sealed by a white colour cloth as the exhibit marked as "A3" in presence of witnesses.

However, on the spot none of civil witnesses were willing to put their signatures on the seizer memo. Over and above there is a possibility of occurring a mob by the locality at that time. So, the seizure memo is prepared without the civil witness. Later, arrested the person on the spot at 07:25 pm of 25/06/2019 from Lilong Kaleikhong near Bridge and seized the above mentioned articles from his possession by observing formalities.

The arrested person mentioned above along with the seized articles are handed over to you for taking further necessary legal action against him.
