Subject: - Report

Madam,

I have the honour to state that on 08/07/2019 at about 09:00 pm received reliable information about the presence of some unlawful arms & ammunitions at Lilong Alia Lamkhai area near Litan Makhong. Accordingly a combine team of District Police Thoubal led by Shri Sachidananda Soibam, MPS, Addl. SP (OPs), a team of Lilong PS led by ASI Laishram Tikendro and a column of 26th Assam Rifles rushed to the said spot at 09:45 pm. Then the combine team started to search the said area i.e. Lilong Alia Lamkhai, Litan Makhong in that one gunny bag was found lying near the Zam Zam Tailoring shop in a very suspicious manner. On opening the said gunny bag found one country made AK, one Magazine and 3 live round ammunitions. Accordingly the said illegal arms and ammunitions were seized on the spot at 09:55 pm by preparing a formal seizure memo in the presence of witnesses. Then the seized arms and ammunitions were brought to Lilong PS and handed over to you for necessary legal actions.
