Sir,

I have the honour to report that today i.e.09/07/2019 at about 7:10 a.m. received a specific information that some stolen vehicles were kept concealed at the house of Syed Azad(19) s/o. Syed Heshamuddin of Lilong Haoreibi Awang Leikai near Tera Makhong L.P Madrassa. Acting on the information, I along with my team assisted by Jem Amin Khan and Hav. Md. Shahidur Rahaman immediately rushed to the said house and conducted searched. In that, 01 (one) Alto Car Silky Colour bearing registration No. MNO7D/4556, Chassis No. MA3EAA61S01052408, Engine No. F8DN4470696 and 1 (one) Royal Enfield Bullet Black in colour without registration number bearing chassis No. ME3U3S5C1CA525326 and Engine No. U3S5C1GA099355 suspected to be stolen vehicles were recovered from his house. Hence, he was arrested at 7:30 a.m. and seized the said vehicles at 7:40 a.m. from his house by observing formalities.

On preliminary verification, he disclosed that the said vehicles were stolen by Md. Ushman Gani of Lilong Awang Leikai (Sambrukhong).
