Sub: - Report.

Sir,

I have the honour to report that today i.e. 20/07/2019 at 02:30 pm I along with my team was conducting normal frisking and checking at Lilong Ushoipokpi Bazar near Lilong Chingkhram Lamkhai along the NH-102 under the command of Shri Sachidananda Soibam, MPS, Addl. SP (Ops/TBL). At about 03:00 pm we stopped one Maruti Van B/Rgd. No. MN01G-4408 silver in colour plying from Thoubal side towards Imphal side. When we about to check the Maruti Van, one passenger suddenly jumped down from the said vehicle and tried to run away. On his suspicious nature, we detained him at the spot. On verification, he identified himself as Angom Sandish Singh (25) s/o Angom Umabati of Awang Sekmai Parao, Imphal West Dristict. It was noted that his right palm was fisting off and suspected for concealing some suspected objects/articles on his right hand palm. On asking, he disclosed that he held some medicines on his right hand palm. Being suspicious, I asked him to open his right hand palm. When he opened his right hand palm, found one plastic container labelled as RASGOLA having red colour lid. Then, I opened the container in presence of witnesses and Gazetted Officer namely Shri Sachidananda Soibam, MPS, Addl. SP (Ops/TBL) and found brown colour powder suspected to be Heroin No. 4 (Opium derivatives). On weighing, it weighed 03(three) grams excluding the weight of the container. Then I transferred all the powder suspected to be Heroin No. 4 (Opium derivatives) to the original plastic container labelled as RASGOLA and tightened the lid. The original plastic container labelled as RASGOLA containing suspected to be Heroin No. 4 (Opium derivatives) is marked as "A" for identification and put inside a yellow envelope and marked as "A" as original sample exhibit. I did not extract duplicate and parent sample exhibits as the quantity of drugs is very less. The original sample exhibit marked as "A" was packed and sealed with wax in presence of witnesses.

So, the above mentioned person was arrested at 03:50 pm of the day and seized the 03(three) grams of brown colour powder suspected to be Heroin No. 4 (Opium derivatives) from his possession at 03:55 pm at the spot by preparing a formal arrest memo and seizure memo.

On preliminary inquiry, the arrested person disclosed that he is a drug user and he bought the seized drugs from Moreh.

The arrested person mentioned above along with the seized articles has been handed over to you for taking further necessary action.
