Today i.e. 23.07.2019 at around 06:30 am received reliable information from my own source that one **Md. Ziaul Haque** aged about 28 years S/O Md. Abdul Salam of Lilong Haoreibi Turel Ahanbi Ubakthong Makha is selling illegal contraband drugs at his house for his personal gain and some quantities of the said drugs is there at his house. Then, I reduced the said information into writing and sent a similar copy to the SP, Thoubal. Immediately, two teams of Lilong P.S. led by me, assisted by ASI Longjam Surchandra Singh of Lilong P.S. under the overall supervision of Shri Dr. S. Bomcha Singh, MPS, Superintendent of Police, Thoubal District, Manipur rushed to the said spot. On reaching spot at 07:20 am, the police team strictly cordoned the house. Then our police team call out the family members in that one who identified himself as **Md. Ziaul Haque**, 28 years S/O Md. Abdul Salam of Lilong Haoreibi Turel Ahanbi Ubakthong Makha came out of the house. Then I informed him that we would like to conduct search of his house in the presence of civil witnesses. With his consent, I call one civilian to be the witness while searching the house and the police team started to search the house. On searching the house found one lady's hand bag hanging in the wall along with some clothes in a very suspicious manner. Then I opened the said bag in the presence of civil witness and found some quantities of blue colour cylindrical capsules suspected to be Spasmo Proxyvon Capsules, inside one transparent plastic polythene. On counting the said capsules it counts 1,287 (one thousand two hundred and eighty seven) nos. of the said capsules. Then I measured the total weight of the said capsules in that it weighed 785.2 grams.

Also found one DBBL gun marked as "HEMRAJ GUN MFRS" bearing No.12845-13 inside the bedroom near a wooden almirah of the said **Md. Ziaul Haque** (28) S/O Md. Abdul Salam of Lilong Haoreibi Turel Ahanbi Ubakthong Makha. When asked about the said DBBL gun he cannot produce any relevant documents about the said gun.

On further searching the house, detected one gunny sack in the back side of the said house near one chicken cage, containing some nos. of bottles suspected to be Cough Syrup bottles. Then I opened the said gunny sack in the presence of civil witness and found illegal Cough Syrup bottles marked as "**DelStal POTENT COUGH SYRUP** containing 10 mg of contraband Codeine Phosphate per 5ml". On counting the said bottles found 135 (one hundred and thirty five) nos. of the contraband cough syrup bottles. Out of which, 2 (two) nos. of the said cough syrup bottles were taken out and put inside two yellow envelopes with 1(one) bottle each packed and sealed and marked as "C1" and "C2" as original and duplicate exhibits respectively. And the remaining 133 (one hundred and thirty three) nos. of the said Cough syrup bottles were put inside the said gunny sack and later wrapped with white cloth then sealed and marked as "C" as Parent Exhibits.

Out of the 1287 nos. suspected SP capsules, 20 nos. of same capsules were taken out and put inside two yellow envelopes with 10 nos. of the same capsules each, packed and sealed and marked as "S1" and "S2" as original and duplicate exhibits respectively. And the remaining 1,267 (one thousand two hundred sixty seven) nos. of the suspected SP capsules were put inside the transparent plastic polythene and again put inside another yellow envelope, packed and sealed and marked as "C" as Parent exhibit.

Then, arrested the accused person namely **Md. Ziaul Haque** aged about 28 years S/O Md. Abdul Salam of Lilong Haoreibi Turel Ahanbi Ubakthong Makha on the spot at 08:50 am. And seized all the packed and sealed drugs were seized from the unauthorised possession of the arrested accused person by preparing a formal weighing & seizure memo in the presence of civil witness at 09:00 am. Also seized the said DBBL gun from the possession of the accused person at 09:05 am.

Hence the arrested person along with the seized articles were brought to Lilong PS and registered a Suo Motto case under **FIR No. 77(07)2019, LIL PS U/S 21(C)/25 ND & PS Act and 27 Arms Act** for investigation
