Today i.e. 25/07/2019 at around 07:00 am based on a specific information from my own source that one Md. Mujibur Rahaman aged about 38 years S/O Md. Salauddin of Lilong Haoreibi Turel Ahanbi near Kaleikhong bridge is selling illegal drugs at his house for his personal gain and some quantities of the said drugs are still there at his house. Then, I reduced the said information into writing and sent a similar copy to the SP, Thoubal. Immediately, two teams of Lilong P.S. led by me, assisted by A.S.I. Laishram Tikendro of Lilong P.S. under the overall supervision of Shri Dr. S. Ibomcha Singh, MPS, Superintendent of Police, Thoubal District, Manipur rushed to the said spot. On reaching spot at 07:40 am, the police team strictly cordoned the house. Then our police team call out the family members in that one Md. Mujibur Rahaman aged about 38 years S/O Md. Salauddin of Lilong Haoreibi Turel Ahanbi near Kaleikhong bridge came out of the house. Then I informed him that we would like to conduct search of his house in the presence of civil witnesses. With his consent, I call one civilian to be the witness while searching the house and the police team started to search the house. On searching the wooden cupboard of his house found some blue colour cylindrical capsules suspected to be Spasmo Proxyvon Capsules inside one transparent plastic polythene.

On counting the said suspected SP capsules in the presence of civil witness, it counts 853 (eight hundred and fifty three) nos. of suspected SP capsules. Then I measured the total weight of the said capsules in that it weighed 715.8 grams. Out of the 853 nos. of suspected SP capsules, 20 nos. of the same capsules were taken out and put into 2 (two) yellow envelopes with 10 nos. of the capsules each, packed and sealed and marked as "A1" & "A2" as Original and Duplicate sample exhibits respectively. And the remaining 833 (eight hundred and thirty three) nos. of the capsules were put inside the original transparent plastic polythene and put inside another yellow envelope packed and sealed and marked as "A" as Parent sample exhibit.

Later, arrested the accused person namely **Md. Mujibur Rahaman** aged about 38 years S/O Md. Salauddin of Lilong Haoreibi Turel Ahanbi near Kaleikhong bridge on the spot at 08:15 am. And seized all the packed and sealed drugs from the unauthorised possession of the arrested accused person by preparing a formal weighing & seizure memo in the presence of civil witness at 09:10 am.

Hence the arrested person along with the seized articles were brought to Lilong PS and registered a Suo Motto case under **FIR No.79(07)2019 LIL-PS U/S 21(C)/25 ND & PS Act** for investigation.
