I have the honour to report that on 26/7/2019 at about 10:30 pm, my son namely Md. Islamuddin @ Bubu (30) S/o (L) Md. Alimuddin of Lilong Haoreibi Makha Leikai got bullet injuries on his forehead and right ear when he was at the gate our house. Later, it was learnt that one individual namely Md. Sabir Ahamed @ Boycha (27) S/o Md. Meheruddin of Lilong Haoreibi Makha Leikai fired the bullet from his license double barrel gun when he was fighting with some of our localities namely Md. Naha S/o (L) Md. Habibula and his two brothers Md. Atao and Md. Ayub Khan at a place near our house. My son was evacuated to the Advance Hospital, Palace compound for medical treatment.

So, it is therefore requested you to take up necessary legal action against the culprits.
