On 10/08/2019 at about 7:30 pm while I was doing duty at Lilong Bazar area, received a reliable information from one unknown informant that some drugs peddlers are going to deal a big consignment of illegal drugs at Nungai area. After verifying the veracity of the source report, I have given telephonic information to SP, Thoubal for information instead of writing down the information in paper, as there is chances of escaping the culprits and concealing the drugs. Immediately, self with a police team of Lilong PS assisted by SI W. Manitomba Singh of Lilong PS and along with members of a CSO of Lilong "ALADA" under the supervision of SP/TBL rushed to the said place i.e. along IVR of Lilong Nungei road at Lilong Nungei Awang Leikai. On reaching the informed place, our police team and members of ALADA wait for some time looking for any suspicion and at about 08:30 pm one D/Auto rickshaw bearing registration no. MN 01L 1589 with one driver and one occupant coming from Lilong Nungei toward Lilong Dam side in a very suspicious manner. On suspicion, when our Police team tried to stop the said D/Auto, the said D/Auto tried to flee away taking a sudden U turn. However our police team overpowered the vehicle and stopped the vehicle. Then our police team asked the driver of the vehicle and the occupant to get down of the vehicle for verification. On verification, they identified themselves as **(1) Md. Amar Khan (22)** S/O Md. Nurhak of Thoubal Moijing Konjin Leikai and **(2) Md. Doctor Rahaman (28)** S/O Md. Muhibur Rahaman of Khekman Amakcham (driver of the D/Auto).

Then, I along with our police team started to search the vehicle. On searching the vehicle, found one black colour polythene which was kept concealed beneath the seat of the occupants in the middle of the vehicle. Then I opened the black colour polythene in the presence of civil witnesses and found yellowish colour powder contained inside one transparent plastic which is suspected to be Heroin no. 4. On measuring the weight of the suspected Heroin powder, in the presence of civil witnesses, by using the weighing machine brought by us, it weighed 168 grams, excluding the weight of the transparent plastic, wrapping the said powder. Then out of the said 168 grams of Heroin no. 4, 2 (two) grams of the same are taken out, divided with one gram each and put inside two transparent small packets and again put inside 2 yellow envelopes, packed and sealed and marked as "H1" and "H2" as original and duplicate sample exhibits respectively. And the remaining 166 grams of the said powder is put inside the original transparent packet and put inside another yellow envelope, packed and sealed and marked as "H" as parent sample exhibit.

Thus the packed and sealed drugs were seized on the spot by preparing a formal weighing and seizure memo in the presence of civil witnesses from the unauthorised possession of **Md. Amar Khan (22)** S/O Md. Nurhak of Thoubal Moijing Konjin Leikai at 09:45 pm. Also seized the involved D/Auto Rickshaw bearing registration No. MN 01L-1589 at 09:50 pm and arrested the driver and the occupant of the D/Auto namely **(1) Md. Doctor Rahaman (28)** S/O Md. Muhibur Rahaman of Khekman Amakcham (driver) and **(2) Md. Amar Khan (22)** S/O Md. Nurhak of Thoubal Moijing Konjin Leikai by observing formalities at 09:55 pm.

Hence, the packed and sealed drugs and arrested individuals were brought to Lilong P.S. and registered a case under **FIR No. 85(08)2019, LIL PS U/S 21(C)/29/60 ND & PS Act** for investigation.
