Today, i.e. 19.09.2019 at around 12:30 am received a specific information from my own source that one drug peddler namely **Md. Rafijuddin(35)yrs. S/o. Md. Safaouddin of Lilong Chingkham Makha Chingjao** is selling illegal drugs at his house for his wrongful personal gain and some quantity of the said drugs are kept concealed at his house. Then, I prepared a source report by recording his statements and sent a similar copy to the SP, Thoubal. Immediately, I along with a team of Lilong Police Station under the supervision of Dr. S. Ibomcha Singh, MPS, Superintendent of Police, Thoubal District, Manipur rushed to the said place i.e. at Lilong Chingkham Makha Chingjao along with the volunteers of Anti Drug Organisation Lilong Chingjao.

On reaching the place at 1:35 am, our police team rushed to the house of **Md. Rafijuddin S/o. Md. Safaouddin** and met a person rushed into a house in a suspicious manner then our team and the volunteers of Anti Drug Organisation detained the person. On verification the person was identified himself as **Md. Rafijuddin(35) yrs. S/o. Md. Safaouddin of Lilong Chingkham Makha Chingjao**. On interrogation he stated that he concealed some SP capsules at the back side of his house beneath a wooden chair. Further our police team searched the area and found a black colour polythene containing some suspicious items beneath a wooden chair.

On opening the black colour polythene, found containing blue colour cylindrical capsules suspected to be SP capsules. Then I count the total nos. of the said capsules, in that found 308 (Three Hundred and eight) nos. of suspected Spasmo Proxyvon Capsules. On weighing the suspected SP capsules in the presence of civil witnesses found 184 gm. Out of which 20 nos. of the suspected SP capsules were taken out and put inside two yellow envelopes with 10 nos. each, packed and sealed and marked as "S1" and "S2" as original and duplicate exhibits respectively. And the remaining 288 (Two hundred and eighty eight) nos. of the suspected SP is put inside the original plastic black colour polythene and put inside a yellow envelope, packed and sealed and marked as "S" as Parent exhibit.

Therefore, the said packed and sealed drugs were seized from the unauthorised possession of **Md. Rafijuddin(35)yrs. S/o. Md. Safaouddin of Lilong Chingkham Makha Chingjao** from his house by preparing a formal weighing & seizure memo in the presence of civil witnesses at 2:00 am and also arrested him from the spot at 2:15 am.

Hence a suo-motto case under **FIR No. 100(09)2019, LIL PS U/S 21(b)/29 ND & PS Act** is registered for investigation.
