Subject: Report

Sir,

With due respect, I the undersigned have the honour to report that, today i.e., 25th July, 2019 at about 8.30 am, while I was at my office, one of my source men came and informed me that, one persons namely, M.Thangsuanmung Zou (46) S/o Hangkhokam Zou of H/No. 117, Zalenphai III, Moreh Ward No. 2, Tengnoupal District, Manipur is going to sell some quantity of Heroin powder at along Tiddim Road, near Kwakeithel Police Outpost, Kwakeithel, Imphal Manipur. Accordingly, I had taken down the information in writing and a copy of the same was forwarded to the Superintendent of Police, NAB for kind information and further necessary action. Immediately, I along with SI Kh.Bungcha Singh and my team including the source man with necessary equipments rushed towards the said area without obtaining search order/warrant as there was great chance of escape of the persons. On reaching at the said place at about 9.00 am, one person was seen standing holding a white colour polythene bag along the Tiddim Road near Kakwakeithel Out-Post as indicated by the source man. Immediately, I along with my team detained the said person at the spot for verification and checking. On verification, he identified himself as M. Thangsuanmung Zou (46) S/o Hangkhokam Zou of H/No. 117, Zalenphai III, Moreh Ward No. 2, Tengnoupal District, Manipur. Then, two persons available at the spot were requested to be witness to which they agreed while conducting some legal procedure. Further, the detainee was told that he was suspected for carrying heroin powder and his belongings need to be checked. Further, information was given to him about his legal rights to be searched in presence of Magistrate or Gazetted officer. In that, he opted to search him and his belongings without Magistrate or Gazetted. However, I conducted his search in the presence of two independent witnesses. On personal search of the detainee, M. Thangsuanmung Zou (46) S/o Hangkhokam Zou of H/No. 117, Zalenphai III, Moreh Ward No. 2, Tengnoupal District, Manipur found one purse, brown in colour containing one Aadhar card having No. 7591 0856 9387 and Rs. 700/- Indian Currency and one Samsung Mobile handset having mobile no. 9366003208. On further search of the polythene bag, white in colour which the detainee namely, M. Thangsuanmung Zou (46) S/o Hangkhokam Zou of H/No. 117, Zalenphai III, Moreh Ward No. 2, Tengnoupal District, Manipur was found holding one plastic polythene carry bag white in colour, on opening it, found another transparent polythene packet containing white colour powder suspected to be Heroin powder and was marked as A for identification. On testing with the Field Testing Kit by taking out a pinch of the said powder from the packet marked as A, it gave positive result to the test for Heroin. On weighing, found weighing 580 grams excluding the weight of the containers.

Then, 10 gm of heroin powder was taken out from the packet marked A which was divided into two equal parts of 5 gm each of heroin powder and put inside two separate polythene packets each and again inserted inside two separate yellow paper envelopes which was properly packed sealed and marked as A₁ and A₂ as original and duplicate samples respectively. The remaining Heroin powder i.e., 570 grams were put inside its original container and inserted in a cartoon box wrapped with white cloth which is properly packed and sealed marked as 'A' as parent exhibit.

Hence, the detected articles i.e. (i) 580 grams of Heroin powder (including the samples), (ii) One purse, brown in colour, (iii) One Aadhaar Card bearing No. 7591 0856 9387 in the name of M. Thangsuanmung Zou, (iv) Rs. 700/- (Rupees, Seven hundred only in denomination of 500x1; 50x4) Indian Currency and (v) one Samsung Mobile handset having mobile no. 9366003208 were seized from the possession of M. Thangsuanmung Zou (46) S/o Hangkhokam Zou of H/No. 117, Zalenphai III, Moreh Ward No. 2, Tengnoupal District, Manipur at 9.25am of the day by making a weighing and seizure memo. Subsequently, he was arrested at 9.30 am of the day.

Thereafter, I obtained the signatures of the arrestee and the witnesses on the weighing and seizure memo, arrest memo, and the exhibits in which I, myself also put my signatures on the same. Thereafter, the seized articles along with the arrested person were handed over to OC NAB-PS Manipur for taking further necessary action as per provision of law.
