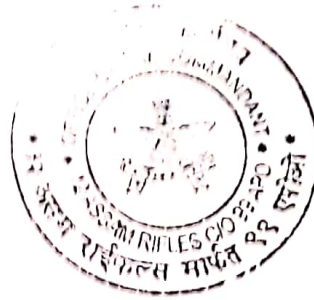

FIRST INFORMATION REPORT (FIR)

On 11 Aug 2019 at around 1300 hrs. based on specific input received from reliable source regarding smuggling of Contraband item and Drugs. A Silver colour Ecco Van, bearing registration No. 12-08-094 travelling from Moreh to Imphal for checking, the PVCP Khudengthabi, 12 Assam Rifles was checking. While checking the van and carrying out thorough checking, under mention, suspected 12 Assam Rifles suspected Brown Sugar and suspected Heroin (white powder) were recovered hidden below the cement bags of the Ecco Van being driven by an individual namely **Khailianmang** and his address are as under:-

(a) MrKhailianmang, Age - 32 years, DOB (1987) S/O Mr Nengkhanthang, Lhangnem Village, Churachandpur Sub-Division, Churachandpur, Manipur, 795128.

The following items along with the Ecco Van were seized:-

(a) Suspected to be Brown Sugar - 47 plastic pouches weighing 650grams (approximately), international market value-1,30,00,000/-

(b) Suspected to be Heroin - 04 plastic pouches weighing 50grams(approximately)international market value- 20,00,000/-

(c) Suspected to be W/Y - 50 pkt (approx 10000Nos) weighing 1.056 Kg (approximately)

The individual in the vehicle was arrested along with the suspected W/Y tab, suspected Brown Sugar and suspected Heroin (white powder).

You are requested to lodge an FIR in this regard and book the individual as per requisite law.
