
FIRST INFORMATION REPORT (FIR)


On 20 Aug 2019 at about 1630 hrs. based on specific report received from reliable source regarding smuggling of Contraband, a suspected Silver colour King Van bearing reg number No ML-05K-9560 travelling from Moreh to Imphal was stopped at 12 Assam Rifles Khudengthabi by troops of 12 Assam Rifles for checking. While frisking and carrying out a thorough check of the vehicle, 60 packets of a brown coloured powder suspected to be Brown sugar and ten packets of a white coloured powder suspected to be Heroin were recovered concealed inside soap cases which were hidden inside two plastic bags inside a plastic tub. The Vehicle was being driven by Mr Salam Surankumar Singh Age - 41 years, (DOB 13-08-1978) s/o Salam Mangi Singh, Wangjing, Wangjing, Thobal, Manipur - 795148, and the contraband was being transported by a passenger Mr Jangkhon Lungdim, Age - 28 years, (DOB 17-03-1992) s/o Mr Thangkhoon Lungdim, MOLTUK, Village, Moltuh, Pallel, Chandel, Chakpikarong Sub-division, Manipur, 795135.

2. The following items were seized:

- (a) Suspected to be Brown Sugar, Total-70 Pkt weighing 892 grms approximately.
- (b) Suspected to be Heroin, Total-10 Pkt weighing 115 grms approximately.
- (c) Mobile phone MI Note 5 Pro - Nos 01

3. The individual in the vehicle was arrested along with the suspected Brown sugar and Heroin.
4. You are requested to lodge an FIR in this regard and book the individual as per requisite law.
