Subj. - Report

Sir,

With due respect, I have the honour to report that, on 24/08/2019 at @ 4.15 pm, while I was at NAB-PS, one of my source man came to me and reported that, huge consignment of codeine phosphate have arrived at ATC transport godown at Kohrengel Nillakuthi. Accordingly, I have recorded the statement of the source man and reduced in writing and a similar copy of the source report has also submitted to SP/NAB, Manipur for information. Immediately, under the supervision of OC NAB-PS, I along with a police team of NAB-PS and the source man and the necessary equipments rushed at ATC transport godown at Kohrengel Nillakuthi after obtaining search order/warrant. At around 5.10 p.m. as we reached at ATC transport godown at Kohrengel Nillakuthi, as indicated by the source man and the gate taker of the godown was identified as Prabhunath Prasad (12) yrs S/o (1) Mahendra Prasad of Sonwant Village, PO- Sonwant, PS- Krimchidingpur, Uttar Pradesh -233228 and asked him that some contraband drugs have been unloaded in the godown. He and another person namely Fula Tanti (34) yrs S/o (1) Ramchandra Tanti of Laxmipur village, PO- Sarmanja, PS- Sarmanja, Begusarai District, Bihar 851127 were requested to stand as witnesses in searching the godown where they agreed voluntarily. Immediately, I along with my police team and the witnesses search the godown and found 50 cartoon boxes. On opening the 50 cartoon boxes, found 100 bottles each of COERIZ - CDX cough syrup each containing 10 mg of codeine phosphate according to the written label on each bottles, except one cartoon box was containing 81 bottles of codeine phosphate out of 50 cartoon boxes. Then, in presence of the two civil witnesses, I conducted the weighing/counting of the detected codeine phosphate as written in the label and found to be weighing (10mg x 4983 = 4983 grams), 4983 grams in total. As all the bottles are of same size, similar and same label, 2 bottles of COERIZ - CDX syrup each containing 10 mg of codeine phosphate were taken out and inserted in two yellow colour envelopes under packed and sealed with wax of NAB-PS which were marked as 'A₁' and 'A₂' as original and duplicate samples respectively. The remaining 4981 bottles were again put in 13 gunny bags and marked as A, B, C, D, E, F, G, H, I, J, K, L, M. A to I containing 400 bottles of COERIZ - CDX syrup each containing 10 mg of codeine phosphate and M containing 181 bottles of COERIZ - CDX syrup each containing 10 mg of codeine phosphate as parent exhibit and the remaining empty 50 cartoon boxes were put inside two gunny bags containing 25 empty cartoon boxes each marked as 'X' and 'Y' respectively under packed and was sealed of NAB-PS. Accordingly, at about 6.10 pm of the day (24/8/2019) in presence of civil witnesses I have seized i) 4983 bottles of COERIZ - CDX syrup each containing 10 mg of codeine phosphate ii) Invoice iii) Consignee copy & iv) F-WAY BILL SYSTEM by making a seizure memo. On perusal of the seized invoice, I along with police team of NAB-PS rushed towards Amar Agency. On reaching Governor Road, Imphal an inquiry has been made for where about the Amar Agency and it comes to know that Amar Agency has been shifted to Thangal Bazar besides Shankar Hotel (tea hotel). Accordingly, I along with my team of NAB-PS rushed to the Amar Agency. On reaching the said place, the manager of the Amar Agency has been detained for verification and checking and on verification, he disclosed his identity as Md. Yashin Mohtammaxum (20) yrs S/o Md. Rahimuddin of Thoubal Kelbung Makha Leikai Ap Hatta Minuthong and we also identified ourselves as police personnel of NAB-PS. On further examination he admitted that he has placed an order of 50 cartoon boxes of COERIZ - CDX syrup each containing 10 mg of codeine phosphate.

Accordingly, his body was searched in presence of the witnesses and found one MI Redmi 6A mobile phone, black in colour from his possession and was seized at 10:20 p.m. Accordingly, he was arrested at 10:30 pm of the day (24/08/2019) as he is the ownership of the seized drugs.

Thereafter, I obtained the signatures of the arrestee and the witnesses on the weighing and seizure memo, arrest memos, seizure memos, and the exhibits in which I, myself also put my signatures on the same. Thereafter, the seized articles along with the arrested person were handed over to OC NAB-PS Manipur for taking further necessary action as per provision of law.
