

Sir,

I have the honor to report that on 26/02/2019 at about 10:30 pm while my husband namely Mr. Abdul Gaffar (serving as mullam carpenter) at Manipur rifle posted at 8th MR Chandel) aged about 54 yrs s/o Late Mr. Tom of Lilong Haakreibi Makha Leikai Zairakthong was sitting alone near the Imphal river bank near his house, he was physically assaulted by one Mr. Mustafa (24) s/o (4) Mr. Nasir of Lilong Haakreibi Makha Leikai Zairakthong without any reason by holding deadly weapon sword. As a result of which, my husband received serious injuries on his persons (head) and evacuated to RIMS Hospital for medical treatment.

So, it is requested to take up necessary legal action against the culprit Mr. Mustafa. I could not report in time as I was engaging with the treatment of my husband.
