Today i.e. 28.08.2019 at around 05:00 pm received specific information about the sale of illegal drugs at the house of **Miss Sureiya @ Naha** (26) D/O (L) Md. Bhaktajaman of Lilong Haoreibi Sambrukhong Mayai. Then I quickly reduced the said information into writing and sent a similar copy to Superior Officer. Immediately I along with my team and the volunteers of All Lilong Anti-Drug Association (ALADA) rushed to the said house. On reaching the house at about 05:40 pm our police team cordon the house very strictly and call out the family members of the house, in that one who identified herself as one **Miss Sureiya @ Naha** (26) D/O (L) Md. Bhaktajaman of Lilong Haoreibi Sambrukhong Mayai came out of the house. Then I informed her that I have got the information that she is selling illegal drugs at her house so our police team would like to search her house. Also I convinced her to surrender any illegal drugs if she has at her house before we search the house. Then our police team along with the volunteers of ALADA entered the house and then she bring out one black colour plastic polythene containing some quantities of Heroin no. 4, which was previously kept concealed at the cupboard of her kitchen.

On opening the black colour polythene, found one transparent plastic pouch containing some yellowish substances suspected to be Heroin No. 4. Then I measure the weight of the suspected Heroin no 4 by our weighing machine brought by us and found to be 10 grams excluding the weight of the plastic pouch. Out of which 2 grams of the suspected Heroin no. 4 were taken out and put inside 2 transparent plastic packets with 1 gram each and again put inside two yellow envelopes packed and sealed and marked as "A1" and "A2" as original and duplicate sample exhibit respectively. And the remaining 8 grams of suspected Heroin no. 4 were put inside the original plastic pouch and put inside another yellow envelope packed and sealed and marked as "A" as parent sample exhibit.

Hence, arrested the individual namely **Miss Sureiya @ Naha** (26) D/O (L) Md. Bhaktajaman of Lilong Haoreibi Sambrukhong Mayai on the spot for the unauthorised possession of illegal drugs at 06:20 pm and also seized the packed and sealed drugs from her possession at 06:30 pm. Further our police team conducted search of her, to ascertain whether any illegal drugs is left or not. However no any illegal drugs were found further at her house.

Therefore the arrested accused person along with the seized drugs were brought to Lilong PS and registered a case under **FIR No. 89(08)2019, LIL PS U/S 21(b)/25 ND & PS Act.**
