

On 28/08/2019 at around 09:10 pm I along with my police team conducted random frisking and checking at Lilong Haoreibi Sambrukhong Makok at the IVR along of Lilong Haoreibi Makha Leikai road in that at around 09:30 pm one person came out of Lilong Haoreibi Sambrukhong in one Yamaha Facino vehicle, red in colour. On seeing our police team the rider of the vehicle tried to take U turn and then attempted to flee away from the spot by leaving the vehicle in a very suspicious manner. On seeing his suspicious nature our police team chased him and managed to detain him for verification. On verification he identified himself as one **Md. Rafique @ Mujibur (35) S/o (L) Md. Abdul Manan** of Lilong Sambrukhong. On opening the tool box of the Facino vehicle found one black & white colour carry bag containing 5 nos. of Cough Syrup bottles marked as "**CodyLate**" containing 10 mg of illegal Codeine phosphate per 5ml.

Out the 5 nos. of illegal cough syrup bottles, 2 bottles were taken out and put inside two yellow envelopes with one bottles each, packed and sealed and marked as "A1" and "A2" as original and duplicate sample exhibits respectively. And the remaining 3 nos. yellow envelopes packed and sealed and marked as "A" as parent sample exhibit.

Therefore the said packed and sealed illegal drugs and the Yamaha Facino bearing registration no. MN 06SB 9625 were seized on the spot from the possession of **Md. Rafique @ Mujibur (35) S/o (L) Md. Abdul Manan** of Lilong Sambrukhong by preparing a seizure memo at 09:55 pm. Also arrested the accused person on the spot for the unauthorised possession of illegal drugs at 10:00 pm.

On spot interrogation, he disclosed that some more quantities drugs were still at his house. Then I informed the volunteers of All Lilong Anti-Drug Association (ALADA) to be witnesses. Later I along with my team and the volunteers of ALADA rushed to the house of **Md. Rafique @ Mujibur (35) S/o (L) Md. Abdul Manan** at Lilong Sambrukhong. On reaching the house at 10:20 pm, our police team cordoned the house very carefully and our police team along with the volunteers of ALADA and the arrested accused person went inside his (arrested accused person) bed room. In that he produced one white colour carry bag which was found hanging at the wall of his house. On opening the white colour carry bag found one transparent plastic polythene containing some blue colour cylindrical capsules suspected to be SP capsules and 4 nos. of Cough Syrup bottles without label. Then I measured the total weighed of the suspected SP capsules in the presence civil witnesses and found 88.8 grams and on counting the said SP capsules, found 119 nos. of suspected SP capsules.

Out of the 119 nos. of suspected SP capsules, 20 nos. of the same capsules were taken out and put inside two yellow envelopes with 10 nos. each, packed and sealed and marked as "B1" and "B2" as original and duplicate sample exhibits respectively and the remaining 99 nos. of the same SP capsules were put inside another yellow envelope and packed and sealed and marked as "B" as parent sample exhibit.

And out of the 4 nos. of Cough Syrup bottles without label 2 nos. of the same bottles were taken out and put inside two yellow envelopes with 1 bottles each, packed and sealed and marked as "C1" and "C2" as original and duplicate sample exhibits respectively and the remaining 2 nos. of the same Cough Syrup bottles were put inside another yellow envelope and packed and sealed and marked as "C" as parent sample exhibit.

Therefore, the packed and sealed drugs were seized from the unauthorised possession of **Md. Rafique @ Mujibur (35) S/o (L) Md. Abdul Manan** of Lilong Sambrukhong at 10:50 pm in the presence of civil witnesses.

Hence the arrested accused person along with the seized articles were brought to Lilong PS and registered a case under **FIR NO. 90(08)2019, LIL PS U/S 21(b)/25/60 ND & PS Act.**
