Today i.e. 31/08/2019 at about 05:10 pm, based on specific information from my own source that some drugs peddlers are going to deal a consignment of illegal drugs at Chongtham Nungei near Leima Ching. After verifying the veracity of the source report, I have given telephonic information to SP, Thoubal for information instead of writing down the information in paper, as there is a chance of escaping the culprits and concealing the drugs. Immediately, self along with police party of Lilong PS assisted by SI. Md. Wakibuddin and ASI. L. Tikendro of Lilong PS along with the civil organization ALADA and ANJUMAN. On reaching the place, one Honda Activa white in colour bearing Regd. No. MN01V-6806 came from Nungei Khongban side was stop for verification. The Honda Activa rider after stopping the vehicle tried to run away but our team managed to catch hold of him. On verification, he identified himself to be Md. Iliyas @ Tomba (65) yrs, S/o. (L). Md. Najimuddin of Moijing Makha Leikai. On opening the tool box of the Honda Activa, found two soap caps colouring red and pink. On opening the red and pink soap caps and found suspected to be Heroin powders. On weighing by the electronic weighing machine which was brought by us, its weights 34.9 grams in red colour soap cap and 10.5 grams in pink colour soap cap.

Out of 34.9 grams in red colour soap cap, 1(one) gm of suspected heroin powder each were collected from the transparent polythene bag and put into two transparent plastic pouch and then packed and sealed in two yellow colour envelopes marked as "R1" and "R2" as original and duplicate exhibits respectively and remaining 32.9 grams of suspected heroin powder was put into transparent plastic pouch along with red colour soap cap and packed and sealed in a yellow colour envelope marked as "R" as parent exhibit.

Out of 10.5 grams in pink colour soap cap, 1(one) gm of suspected heroin powder each were collected from the transparent polythene bag and put into two transparent plastic pouch and then packed and sealed in two yellow colour envelopes marked as "P1" and "P2" as original and duplicate exhibits respectively and remaining 8.5 grams of suspected heroin powder was put into transparent plastic pouch along with pink colour soap cap and packed and sealed in a yellow colour envelope marked as "P" as parent exhibit.

On spot interrogation, Md. Iliyas @ Tomba reveals that he is a drugs dealer and trafficker. Thereafter, I arrested the accused person namely Md. Iliyas @ Tomba (65) yrs, S/o. (L). Md. Najimuddin of Moijing Makha Leikai at 07:30 pm for possessing and transporting controlled drugs and seized the detected drugs from the unauthorized possession of Md. Iliyas @ Tomba (65) yrs, S/o. (L). Md. Najimuddin of Moijing Makha Leikai and the six envelopes marked as "R", "R1", "R2", "P", "P1" & "P2" and the Honda Activa bearing Regd. No. MN01V-6806 was seized under a seizure memo by observing formalities at 07:20 pm. I obtained the signatures of the two witnesses and alleged accused Md. Iliyas @ Tomba on the seizure memo and sealed and packed envelopes.

Hence the arrested person along with the seized articles were brought to Lilong PS and registered a suo-motto case under **FIR No. 91(08)2019 LIL-PS** u/s 21(b)/60(3) ND&PS Act for investigation.
