

On 31.08.2019 at around 11:00 pm, I along with A.S.I. Laishram Tikendro of Lilong P.S. and police team were on mobile patrolling along Lilong Chingkhram Makha Iddiga road. On reaching at the crossing of the IVR of Pusham Iddiga, one person was found standing alone in a very suspicious manner. Then our police team detained him for verification. On verification he identified himself as one **Md. Wahidur (30)** S/O Md. Abdul Hekim of Lilong Chingkhram Makha. When I randomly checked his right side pocket of his trouser, found one black colour polythene containing some suspicious items. Then I took out the said black colour polythene and opened it. On opening the black colour polythene found 20 nos. of blue colour cylindrical capsules suspected to be Spasmo Proxyvon Capsules. As it was a random detection, I did not take his option for body search. Then I measure the weight of the said capsules on the weighing machine brought by us, it weighed 11.8 grams.

Out of which, 10 nos. of the same capsules were taken out and put inside two transparent plastic packets with 5 nos. of suspected SP capsules each and again put inside two yellow envelope, packed and sealed and marked as "A1" and "A2" as Original and Duplicate sample exhibits respectively. And the remaining 10 nos. of the same SP capsules were put inside one transparent plastic packets and again put inside yellow envelope, packed and sealed and marked as "A" as Parent Sample exhibit.

Therefore arrested the accused person **Md. Wahidur (30)** S/O Md. Abdul Hekim of Lilong Chingkhram Makha at 11:30 pm and also seized the packed and sealed drugs from his unauthorised possession at 11:40 pm by preparing a formal weighing & seizure memo. However, as it was late night, none of the civil witness was present at the time of seizure. So the weighing & seizure memo was prepared without the civil witnesses.

On spot interrogation, he stated that he is drug peddler and he is waiting for one of his customer who contacted him to buy drugs. On further interrogation he stated that some quantities of drugs are still at his house. Then I inform the volunteers of ANJUMAN Lilong and some of the localities to be witnesses while conducting house search. Then our police team along with the arrested accused person rushed to the house of the accused person and the police team cordoned the house very carefully. In the meantime the volunteers of ANJUMAN and some of the people of the locality came to the house. Then the arrested accused person pointed out the exact place where he kept concealed the said drugs i.e. at the joining cavity of two GI sheets (tin) above roof of his house just above his bed. Then I searched the place where he pointed out and found one transparent plastic containing 21 nos. of blue colour cylindrical capsules suspected to be SP capsules. Then I measure the total weight of the suspected SP capsules and found 12.2 grams.

Out of the 21 nos. of suspected SP capsules, 10 nos. of the same capsules were taken out and put inside two transparent plastic packets with 5 nos. of suspected SP capsules each and again put inside two yellow envelope, packed and sealed and marked as "B1" and "B2" as Original and Duplicate sample exhibits respectively. And the remaining 11 nos. of the same SP capsules were put inside the original transparent plastic packets and again put inside one yellow envelope, packed and sealed and marked as "A" as Parent Sample exhibit.

Therefore the said packed and sealed drugs were also seized from the unauthorised possession of **Md. Wahidur (30)** S/O Md. Abdul Hekim of Lilong Chingkhram Makha at 12:30 am of 01/09/2019 by preparing a weighing & seizure memo in the presence of civil witnesses.

Hence all the packed and sealed seized drugs and the accused persons were brought to Lilong P.S. and registered a case under **FIR No. 92(09)2019, LIL PS U/S 21(b)/25 ND & PS Act.**
