Sir,

I have the honour to report that today i.e. 01/09/2019 at around 03:30 pm, I along with police team of Lilong PS led by Inspt. Oinam Ajit Singh, OC/LIL PS were carrying out mobile patrolling at Lilong Leihakhong side. When we reach Lilong Litan Makhong near the office of ALADA at around 04:00 pm one elderly woman came on foot from Lilong Litan Makhong side towards Lilong Bazar side. On seeing our police team, I can notice some behavioural changes in her movement, all of a sudden. Then she quickly step a side near the bank of Lilong Turel Ahanbi river and threw one plastic polythene in a very suspicious manner. On seeing the suspicious nature, our Police team detained her for verification and also picked up the polythene she had thrown. On verification she identified herself as one **Mrs. Rejiya @ Bobby** aged about 40 years W/O (L) Anwar Hussain of Lilong Haoreibi Lairabakhong. In the meantime the volunteers of ALADA also came towards us and witnessed the activities. On opening the plastic polythene found some reddish colour powder suspected to be Heroin No. 4 inside one transparent plastic packet. Then informed about the matter to our Superior Officers. I measured the weight of the suspected Heroin no. 4 and found 8.3 grams excluding the weight of the polythene container.

Out of which 2 grams of the same were taken out and put inside two transparent plastic packets and again put inside two yellow envelopes, packed and sealed and marked as "H1" and "H2" as Original and Duplicate sample exhibits respectively. And the remaining 6.3 grams of the same were put in the original polythene and put inside another yellow envelope packed and sealed and marked as "H" as Parent sample exhibit.

Therefore the packed and sealed drugs were seized from the unauthorised possession of **Mrs. Rejiya @ Bobby** aged about 40 years W/O (L) Anwar Hussain of Lilong Haoreibi Lairabakhong at 04:30 pm in the presence of civil witnesses and then arrested her on the spot at 04:35 pm of the same day.

Hence the packed and sealed drugs and the arrested accused person were brought to Lilong PS and handed over to you for necessary legal action.
