On 02.09.2019 at around 11:30 pm received a specific input from one of my trusted informer that one **Md. Anwar Khan @ Achouba (26)** S/O (L) Md. Samsurddin of Lilong Chingkhram Makha is selling illegal drugs like Spasmo Proxyvon Capsules, WY tablets and Cough Syrup at his house. Then, I reduced the same information into writing and sent a similar copy to SP Thoubal and also informed him about the information through mobile phone. Immediately two teams of Lilong PS led by myself assisted by SI Md. Isha Khan and ASI Laishram Tikendro of Lilong PS along with the members of Anti-Social Elements Prevention Youth Committee, Lilong Chingkhram rushed to the said spot. On reaching the house at 11:55 pm, our police team cordon the house very strictly. In that one person ran out of the back side door of the house by holding a red polythene bag containing some suspicious items and hurriedly threw the polythene bag inside the bunch of bamboos grown at the backside of his house. Then our police team along with the locals detained him for verification. On verification he identified himself as one **Md. Anwar Khan @ Achouba (26)** S/O (L) Md. Samsurddin of Lilong Chingkhram Makha. Then I took out the red polythene bag from the bunch of bamboos in the presence of the local witnesses.

On opening the red colour polythene bag in the presence of civil witnesses found, (1) one yellowish colour plastic polythene containing blue colour cylindrical capsules suspected to be SP capsules, (2) one blue colour small pouch containing reddish colour tablets suspected to be WY tablets and (3) 2 nos. of cough syrup bottles marked "CodyLate" inside the red colour polythene bag. In the meantime, I informed my Superior Officers about the incident. Then I counted the nos. of suspected SP capsules and found **836 (Eight Hundred and Thirty Six)** nos. of suspected SP capsules weighing **534.6 grams**. And on counting the nos. of suspected WY tablets found **182 (one hundred and eighty two)** nos. weighing **21.5 grams**. The weight of the said capsules and tablets were measured in the weighing machine brought by us.

Out of the 836 nos. of suspected SP capsules, 20 nos. of the suspected SP capsules were taken out and put inside two small transparent plastic packets with 10 nos. of the same capsules each, and again put one packet each inside two yellow envelopes, packed and sealed and marked as "S1" and "S2" respectively as Original and Duplicate Sample exhibits respectively. And the remaining 816 nos. of suspected SP capsules were put inside the original yellowish plastic polythene and put inside another yellow envelope, packed and sealed and marked as "S" as Parent Sample exhibit.

Similarly out of the 182 nos. of suspected WY tablets 20 nos. of the suspected WY tablets were taken out and put inside two small transparent plastic packets with 10 nos. of the same tablets each, and again put one packet each inside two yellow envelopes, packed and sealed and marked as "W1" and "W2" respectively as Original and Duplicate Sample exhibits respectively. And the remaining 162 nos. of suspected WY tablets were put inside the original blue colour small pouch and put inside another yellow envelope, packed and sealed and marked as "W" as Parent Sample exhibit.

And the two Cough syrup bottles marked as "CodyLate" is inside two yellow envelopes with one bottles each packed and sealed and marked as "C1" and "C" as Original and Parent Sample exhibits respectively.

Then the packed and sealed yellow envelopes were seized from the unauthorised possession of **Md. Anwar Khan @ Achouba (26)** S/O (L) Md. Samsurddin of Lilong Chingkhram Makha on the spot at 12:50 am of 03.09.2019 in the presence of civil witnesses and also arrested the accused person on the spot 01:00 am.

Hence all the packed and sealed drugs and the arrested accused person were brought to Lilong Police Station and registered a case under **FIR No. 94(09)2019, LIL PS U/S 21(a)/21(c)/22(b)/25 ND & PS Act.**
