Respected Sir,

I have the honour to lay the following few facts for kind perusal and taking necessary legal action against the accused person.

That, I am a bonafide law abiding citizen of India and a resident of Lilong Haoreibi Turel Ahanbi Dam Mathak under Lilong Police Station, Thoubal District, Manipur and the accused person is my third son.

That the accused person has been threatening me frequently by holding deadly weapons such as daggor, spade etc and has been demanding forcibly to give money for his own use. When I could not pay the money the accused thretend me saying that he would kill me if I do not pay the money.

That, on 30/8/2019 at about 3. 30pm , the accused came near me while I was staying at my house and the accused forcibly asked to give a sum of rupees fifty thousand and the accused suddenly tried to extort the money by threatening me and latter the accused caught hold on my neck and strangulated on my throat in order to kill me and I received serious pain on my throat. In the meantime, my fourth son Md Wahidur Rahman (35) along with some local men came and they saved my life.

That, now the accused is looking chance to kill me at my moment and still demanding the money in question and my left is on panic.

That the accused has committed offences punishable U/S 325/307/384/511/506 IPC.

It is therefore, requested to kindly take up necessary legal action against the accused person for the end of justice.
